## Comments:

The response is made by London Living Streets. Overall the proposals are welcome. However, we would have preferred an area-wide approach to reducing motor traffic in and around Dalston junction.

In relation to this proposal, we are concerned the restricted movements on this junction might result in traffic diverting down residential roads in the neighbourhood such as Richmond Road and King Henry's Walk. We would therefore ask for traffic counts on Richmond Road and King Henry's Walk before and after (6 months- 1 year).

We welcome the positive aspects of the intervention:

- 2.7m wide crossing being increased to 3.2m and 2.2m wide crossings increased to 4.0m.
- Note that diagonal central crossing width will be increased from 4.2m to 5.0m which is welcomed.
- Excellent that crossings will have colour contrasting surface and moved closer to junction centre. Can edges of crossing be clearly contrasted to assist visually impaired people?
- Building out of footways on all sides welcomed
- Closing of Kingsland Passage to traffic with full height kerb across access (continuous footway) welcomed.
