Funding Opportunities – Healthy Streets

- Transport for London/central government
 - 1. TfL Liveable Neighbourhoods Fund grants of between £1m and £10m will be provided for a wide range of community-supported projects. These could include creating green spaces and cycling infrastructure and redesigning junctions. The programme can also fund the widening of walking routes to improve access to local shops, businesses and public transport. The Liveable Neighbourhoods programme will continue until 2022/23 and boroughs can submit bids at any time.  - 3. **Low Emission Neighbourhoods** A Low Emission Neighbourhood (LEN) is a comprehensive package of measures delivered in an area of high pollution and high human exposure.
